## 5. Assistance with Medical Costs by Medical Care Ticket

This is a form of assistance for students approved to receive school expenses subsidies in 2018. In general, patients pay 30% of medical costs, but if a student presents this ticket issued by the Gakumu Section, they can undergo medical treatment of the illnesses below free of charge:

\* You cannot use it at the same time with Child Medical Certificate or Single Parent Medical Certificate.

\* It can be used only by enrollees of Toyonaka municipal elementary or junior high schools.

[Illnesses covered by the Medical Ticket] : Trachoma, conjunctivitis, athlete's foot, scabies, impetigo, otitis media, empyema, adenoids, tooth decay, parasitic disease



# 4. Payment

If your application is approved, we will pay the subsidies into the parent's/guardian's bank account in two installments. Do not close the account until the end of March. 2020. If you would like to change the account for payment of the subsidy, contact Gakumu Section.

※ If you apply after June 18, have not declared your income, or make an incomplete application, you may not be able to receive the subsidy on the payment days in August and February. In such cases, we will inform you of your payment dates in the notice of the results of review.
