5. Assistance with Medical Costs by Medical Care Ticket

This is a form of assistance for students approved to receive school expenses subsidies in 2019. In general, patients pay 30% of medical costs, but if a student presents this ticket issued by the Gakumu Section, they can undergo medical treatment of the illnesses below free of charge:

- *You cannot use it at the same time with Child Medical Certificate or Single Parent Medical Certificate.
- *It can be used only by enrollees of Toyonaka municipal elementary or junior high schools.

[Illnesses covered by the Medical Ticket]: Trachoma, conjunctivitis, athlete's foot, scabies, impetigo, otitis media, empyema, adenoids, tooth decay, parasitic disease

2020 Application for School Expense Subsidies Starts (Shugaku-Enjo)

Toyonaka City Board of Education provides subsidies for school supplies and other necessary expenses for your child at elementary/junior high school. If you would like to benefit from this system, read this letter carefully and submit an application.

To use this system, <u>you must apply each year. Even if you received this subsidy last year, be sure to apply again this year.</u>

©Eligibility Requirements

Parents/guardians of elementary/junior high school students whose total income during 2019 (January through December, 2019) was less than the set amount. **For details, please refer to p.2.

- *The children attending special needs schools will not be covered.
- *Households receiving education assistance under the Public Assistance Act are not eligible. However, if you are still waiting for approval for the Public Assistance, apply for this subsidy, too.

About the Application

As of May 7th, 2020, the "State of Emergency" due to the COVID-19 epidemic remains in effect, so we will accept applications either "at reception desks" or "by mail". The schedule for face-to-face reception "at reception desks" may be changed or canceled suddenly due to the COVID-19 epidemic.

If your application is approved, we will pay the subsidies into the parent's/guardian's bank account in two installments. Do not close the account until the end of March, 2021. If you would like to change the account for payment of the subsidy, contact Gakumu Section.
